**TERMS**

**A non-refundable deposit of one month's tuition is required.** Before June 1<sup>st</sup>, this deposit can be provided in two separate payments. After June 1<sup>st</sup>, the payment is required to be in full. This amount is only applied to June 2023 for both payment options. A completed registration form, this tuition agreement and the remaining post-dated cheques must be remitted before placement can be confirmed. All cheques payable to KW MONTESSORI SCHOOL. Please note, N.S.F. cheques are subject to a penalty of \$50.00 per cheque and late payment of 2% per month. **As an alternative to cheques, parents can opt to register with TUIO for online payments.** Extended hours are not included in the tuition. If registered in Before and After Care programs, monthly fees are to be included with each of the monthly tuition payments, with the exception of the initial registration deposit. When a family has more than one child enrolled in the school the eldest child pays full fees and the second and subsequent children will receive a 10% discount on tuition fees only. KWMS reserves the right to ask a student to be withdrawn if fees are not paid in accordance with the terms outlined in the above payment plans. KWMS reserves the right to dismiss a student if we feel the child is not benefitting from the Montessori program and curriculum that we offer. In this case, any future payments owing will become null and void.

**WITHDRAWAL POLICY**

Should your child be withdrawn from the school during the academic year, one month's written notice is required. All subsequent post dated monthly cheques will then be returned. Because it is difficult to introduce new children to the program in the latter months of the school year, where a child is withdrawn after January 1<sup>st</sup> post dated monthly cheques are not returned, and payment is owed for the remainder of the school year. **The June 1, 2022 installment is only refundable if the school is advised in writing prior to August 1, 2022 that the child will not be attending.**

**RELEASE OF INFORMATION**

We give consent for the transfer of school records to and from K-W Montessori School, as well as give permission for the use of parent and student names, addresses and phone numbers in school directories, the use of names and photographs in school newsletters, yearbook, promotional materials, website promotion, social media, video taping and newspapers and to the display of student work in the classroom, in school publications and during other school related functions. **Parent/Guardian Initial** \_\_\_\_
