

Summer Programs

This summer, we are able to begin offering summer programs for the Young Children's and Casa age levels.

Fees, registration terms and links for the registration forms will be provided to current families. Any non-enrolled family can contact the office for further information. There will be limited spaces available to the public. Any students enrolling in the fall term will have an option to also enroll in the summer program.

Summer Program Hours (all ages):

- 8:45 3:30, drop off available from 8:30 with no additional fee
- Summer After Care is only available until 4:30. We are unable to offer full extended care hours during the summer.
- Fee for aftercare is \$20/wk. (non-base fee)

Please note that just as in the school year, After Care is a mixed program of both licensed and non-licensed children, but the program adheres to all licensing rules.

Young Children's Community

6 week program:

June 23rd to August 1st. ** No program July 1st **

This program is a licensed program and is an extension of the school year program, offering consistency for our youngest students. One of our YCC trained teachers, along with support staff, will run the program. The same daily routine will be followed with some additional time for outdoor summer activities. Those currently enrolled in our school will have priority registration. Those currently on our waitlist will then have access to the remaining spots. Siblings on our waitlist will have priority.

If your child will not be 3 by July, this is the program they would attend. If your child is 3 or older by July, they should be enrolled in the Casa level 1 summer program. Any student currently enrolled in the YCC has the option of enrolling for less than 6 weeks. Any new student entering the program in the summer (and entering our program in Sept.), will be required to register for at least 5 consecutive weeks. Consistency for this age group is key to establishing the feeling of security while transitioning to a new program.

Snacks and lunches are included.

Parents with students on the waitlist will be notified by the office directly if spaces will be available.

Casa Program

5 week program:

Monday June 30th to Fri. August 1st ** No program July 1st**

Our programs for casa children will be run by our teachers along with support staff. This program will follow the same daily routine as the school year, but with additional outdoor time and a variety of additional activities (arts and crafts, active games, music, drama) based on weekly themes. Those currently enrolled in our program will have priority registration.

Casa students will be divided into two groups for the summer program. Casa level 1 and Casa level 2 will function separately from each other, one being licensed, the other termed a 'camp'. The two groups will not share space during the daily program.

<u>Casa level 1</u>: age 3 - 4 yrs (for students turning 4 during the summer or later). Students turning 3 and ready for the casa program may also register for this program. Please speak with the office to confirm appropriate placement. This program is a licensed program and is required to follow ministry licensing guidelines which includes catering requirements just as in the school year. Students 44 mths of age can opt out of the catering option.

There is a catered and non-catered option for this program.

Casa level 2: ages 4 - 6 yrs of age (for students 4 yrs by July 1st or by their first day attendance)

The Casa level 2 will not run as a 'licensed program' under the ministry but will still follow all school policies. This program will be labelled a 'camp' as students are 4 yrs and older.

This is a non-catered program but catering options will be available to parents and Pizza Fridays will also run each week.
